



## CATHOLIC SPECIAL CHARACTER POLICY

### Outcome statement

The Catholic special character of the school is safeguarded and strengthened.

### Scoping

The board will be kaitiaki of the Catholic special character, protecting, preserving, and sheltering this taonga for future generations. The board, management and staff actively support and foster the specific shared Gospel values that the school stands for, both in teaching and the behaviour they model. The wider school community safeguards and strengthens an environment that enables students to develop the attributes, knowledge, and skills to become active and committed members of the faith community and contribute positively to the world community. Students will have the opportunity, within the contest of their own culture to encounter Christ, grow in knowledge of Him and His Church, and to live a life of Christian witness.

### Definitions

Integration Agreement	The Integration Agreement is the Deed of Agreement dated 6th February 1982 as varied by Supplemental Deeds including a Deed of Agreement dated 22 December 1997.
Proprietor	Pursuant to the Integration Agreement the Mission College New Plymouth Trust Board (CC27614) assumes the responsibilities and obligations as the Proprietor for Sacred Heart Girls' College and is known as the Proprietor for the purposes of this policy.

### Delegations

Responsibility and accountability for Catholic special character rests with the whole board, with no individual board member or committee having decision-making authority unless it has been delegated and documented. All sub delegations are approved by the board, as are revocations.

- When making appointments the Board and the Principal will take into account the Catholic Character of the College and will endeavour to ensure that all tagged positions are filled as required by the College's Integration Agreement.
- Make every effort to include daily prayer and regular liturgy as part of student life and of the meetings of the College staff and committees.
- The role of the Chaplain will enhance the Special Character of the College as per their job description.
- The principles of the empowerment of young women by way of Caritas donations and donations to charities which support women and young children are to be encouraged.
